

IMPORTANT INFORMATION REGARDING YOUR LONG DISTANCE SERVICE

Dear Customer,

December 15, 2009



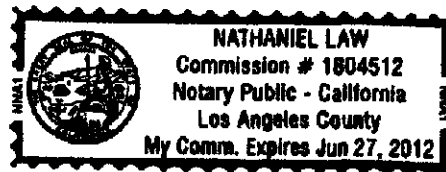

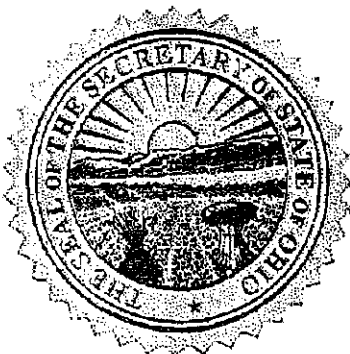
