The Ohio 2 Power Siting Board has assigned for a public hearing 3 at this time and place Case No. 09-750-EL-BSB, 4 captioned "In the Matter of the Application of 5 BP-Husky Refining, LLC, for a Certificate of б Environmental Compatibility and Public Need for a 7 138/69 Kilovolt Substation Project." 8 My name's Rebecca Hussey. I'm the 9 administrative law judge assigned to preside over 10 tonight's hearing. I'll begin by taking appearances 11 from the parties, beginning with the company. 12 MR. BOEHM: Good evening. My name is 13 Kurt Boehm. I'm appearing here on behalf of BP 14 Refining, LLC. 15 MS. HUSSEY: Thank you. Any other 16 parties? Representatives? 17 (No response.) 18 MS. HUSSEY: Okay. On September 23rd, 19 2009, BP-Husky Refining, LLC, filed an application for 20 a certificate with the Ohio Power Siting Board, 21 proposing to construct a 138/69 kilovolt substation in 22 Oregon, Lucas County, Ohio. 23 As part of this proceeding, the staff of 24 the Ohio Power Siting Board completed a staff report

of investigation on January 5th, 2010. Copies of the 2 staff report are available at the entrance where the sign-in sheets are located.

The staff report will likely address any 4 5 questions you may have regarding the application and 6 how the process will proceed this evening. Tonight's 7 public hearing is only part of the overall proceedings in this case. 8

The adjudicatory hearing will commence on 9 10 January 27th, 2010, at 10:00 a.m., at the offices of 11 the Public Utilities Commission of Ohio. And at that 1.2 hearing, BP-Husky Refining and the Ohio Power Siting 13 Board will have an opportunity to present evidence 14 regarding whether BP-Husky Refining's application 15 should be approved.

16 Tonight's public hearing provides an 17 opportunity for members of the public to present their 18 views on BP-Husky Refining's proposed project. We 19 will not be hearing from BP-Husky Refining or the Ohio 20 Power Siting Board staff this evening.

21 Tonight is the public's opportunity to 22 let the board know what you think of the proposed 23 project. You will not have the opportunity to ask the 24 company or staff questions during your testimony, but

1 I would encourage any company representatives to stick 2 around after the hearing in case folks do have 3 questions. As you may have noticed, there's a court 4 5 reporter here, and he'll be transcribing the hearing. 6 What that means is that the court reporter will be 7 recording tonight in typewritten fashion the 8 statements that have been made here today. All of tonight's testimony will be part 9 10 of the record in this case and will be part of the 11 board's consideration of the application. 12 When you arrived, there was a sign-up 13 sheet for anyone who wishes to testify.
