**AMENDMENT TO APPLICATION
FOR REGISTRATION AS A CMRS PROVIDER**

Virgin Mobile USA, L.P. (“Virgin Mobile” or the “Company”), by undersigned counsel, hereby amends its Application for Certification for Status as a Nonrural Eligible Telecommunications Carrier, which it filed in the above-captioned proceeding on February 3, 2010, as follows:

On November 24, 2009, Virgin Mobile became a wholly owned subsidiary of Sprint Nextel Corporation (“Sprint”) upon completion of the companies’ previously announced transaction.¹ As a wholly owned subsidiary of Sprint, Virgin Mobile is registering as a facilities-based provider of wireless PCS services in Ohio. The Company’s prepaid wireless services are provided on Sprint’s nationwide PCS network and available in all Sprint CDMA network territories.
