
**DUKE ENERGY OHIO, INC.'S

SCHEDULED FOR FEBRUARY 25, 2010**

On March 3, 2009, Duke Energy Ohio, Inc. (Duke Energy Ohio) filed its Application for recovery of cost, lost margin and performance incentive associated with the implementation of electric residential and non-residential demand side management programs. On February 17, 2010, an Entry was filed by the Commission ordering a continuation of the hearing to Thursday, February 25, 2010, at 10:00 a.m., at the offices of the Commission 180 E. 
