Sue,

As you are aware the Village's Mayor, Donald J. Gadd, was appointed the "Receiver" of the Rolling Hills Wastewater Treatment Plant (WWTP) on July 12, 2007 by Common Pleas Judge David Ellwood. Under the order of the court, the Village has provided for the operations of the plant, collected all revenues from the customers served by the plant, and paid all expenses associated with the operation of the plant from the date of appointment until present.

Utilities Operators Corporation and Edward Bishoff were found guilty of violating the conditions of the NPDES permit issued by the EPA. Mr. Bishoff and UOC was fined and permanently enjoined from operating the Rolling Hills WWTP.

On July 10, 2009 the Village of Byesville filed with the court a motion requesting relief as the Receiver of the WWTP. The hearing date is set for Friday August 14<sup>th</sup> 2009.

I have attached a copy of the monthly reports of income and expense that were filed with the court each quarter. If you have any questions concerning these reports please feel free to contact me.
