On March 17, 2010, CenturyTel Operating Companies filed Transmittal No. 74, with the Federal Communications Commission. The revisions made to Tariff F.C.C. No. 1 will become effective April 1, 2010. In this filing, CenturyLink adjusts the universal service fund (USF) end user contribution factor for the second quarter 2010 to 0.153 consistent with the requirements of the Commission's USF Order.<sup>1</sup>


