ENTRY

The attorney examiner finds:

- (1) Ohio Edison Company (OE), The Cleveland Electric Illuminating Company (CEI), and The Toledo Edison Company (TE) (collectively, FirstEnergy) are public utilities as defined in Section 4905.02, Revised Code, and, as such, are subject to the jurisdiction of this Commission.
- (2) On March 23, 2010, FirstEnergy filed an application, pursuant to Section 4928.141, Revised Code, for a SSO for the period between June 1, 2011, and May 31, 2014. This application is for an ESP, in accordance with Section 4928.143, Revised Code, and the application includes a stipulation agreed to by various parties regarding the terms of the proposed ESP.
- (3) On March 24, 2010, the attorney examiner issued an entry establishing a procedural schedule (March 24 Entry). The March 24 Entry also granted intervention to those parties who intervened in its recent market rate offer proceeding, Case No. 09-906-EL-SSO.
- (4) Additionally, the March 24 Entry scheduled the evidentiary hearing to commence on April 20, 2010, at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, 11th Floor, Hearing Room 11-A, Columbus, Ohio, and stated that the local public hearings would be scheduled by subsequent entry.
- (5) Pursuant to the March 24 Entry and in order to provide customers of FirstEnergy a reasonable opportunity to provide public testimony in this proceeding, the following local public hearings will be conducted on the following dates:

- (6) Pursuant to Rule 4901:1-35-06(A), O.A.C., FirstEnergy should publish legal notice of the application and scheduled local and evidentiary hearings in a newspaper of general circulation in each county in its service territory. Publication of the notice should be completed by April 16, 2010. The hearing notice

should not appear in the legal notices section of the newspaper. The notice should read as follows:
