Pursuant to this Amendment (the "Amendment") NPCR, Inc. d/b/a Nextel Partners ("Nextel Partners") a Delaware corporation and The Ohio Bell Telephone Company d/b/a AT&T Ohio ("AT&T"), hereinafter referred to collectively as the "Parties" hereby agree to amend that certain Interconnection Agreement between the Parties approved by the Ohio Public Service Commission on December 4, 2001, as amended ("the Agreement").

WHEREAS, Nextel Partners and AT&T Ohio agree to amend the Agreement as set forth herein;

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Sprint and AT&T Ohio hereby covenant and agree as follows:

- 1. The Parties agree to delete Section 11.1 in its entirety and replace it with the following:
  - 11.1 Term. Notwithstanding anything to the contrary in this Agreement, the Term of this Agreement shall commence upon the Effective Date of this Agreement and shall expire on March 24, 2012 (the "Term").
- 2. All other provisions of this Agreement, as amended, shall remain in full force and effect.
- 3. Either or both of the Parties are authorized to submit this Amendment to the appropriate Commission for approval subject to section 252(e) of the Federal Telecommunications Act of 1996.
- 4. This Amendment shall be filed with and is subject to approval by the Commission and shall be effective upon the date of the last signature of both Parties.
