On May 3, 2010, CenturyTel Operating Companies filed Transmittal No. 79 with the Federal Communications Commission. The revisions made to Tariff F.C.C. No. 1 will become effective May 18, 2010. In this filing, CenturyLink proposed the addition of rates and regulations for Local Number Portability (LNP) Query service and is removing the rates and regulations for LNP End User service, which is expired on May 16, 2010.


