Thank you for contacting the Ohio Power Siting Board with information regarding Hardin Wind Energy LLC's proposed installation of a wind turbine electric generating facility located in Hardin County, Ohio. The OPSB's mission is to support sound energy policies that provide for the installation of energy and transmission infrastructure for the benefit of the Ohio citizens, while promoting the state's economic interests and protecting the environment and land use.

Dear Ms. Wissman,

Thank you for your response to my letter concerning Inverenergy's (Hardin Wind LLC) unresponsiveness. Mr. Adum quickly replied in letter format wanting me to sit down to a personal meeting. This seemed to me to be unnecessary with he being from out of state. (See his letter and mine in response accompanying this one.) I am awaiting his response in the mail and will keep you posted.

For memory's sake, I was one of the concerned citizens who was sworn into speak at the Hardin County Court House for the O.P.S.B.'s hearing in January. I had, and still do have, concerns about the close proximity of the placement of the wind turbines in a populated area. An area populated by my family and friends. These concerns have yet been addressed by Inverenergy. So, I am turning to your board. For your convenience in answering them they are at the end of my letter. These must be hard questions to answer since Inverenergy does not want to address them in writing. So I am turning to you.

Maybe some of these concerns were addressed in the portion of their project summary 4606-17-08 with your board? Will you please send it to me along with the answers to the questions contained with this letter as well? (Please see attached.)

Could you, also, please send me information pertaining to how the O.P.S.B. will address problems with turbine placement in relationship to private property owners, health issues, and other impacts on those who live within the wind farm if they happen? If I understand their paper work submitted to you on November 20, they had to do a map. Is this what your board used to make sure "shadow flicker" does not affect anyone's private property or quality of life?

I was reassured by your letter that the O.P.S.B. mission statement included "for the benefit of Ohio citizens" for if these wind farms turn out like the ones with all the problems like ones in other populated parts of the country, the word "benefit" may be the most impacting part. For the rectification of any problems are easier addressed now, than later.

I thank you for your time, help, and replying to my inquiries.
