ENTRY

The administrative law judge finds:

- (1) On January 13, 2010, Paulding Wind Farm, LLC (applicant) filed, with the Ohio Power Siting Board (Board), an application for a certificate to site a wind-powered electric generation facility in Paulding County, Ohio, pursuant to Chapter 4906-17, Ohio Administrative Code (O.A.C.).
- (2) By entry issued February 23, 2010, the motion to intervene filed by the Ohio Farm Bureau Federation (OFBF) was granted.
- (3) By entry issued April 5, 2010, a procedural schedule was established in this matter that, inter alia, required that all expert and factual testimony to be offered by the applicant be filed by June 15, 2010, while setting June 22, 2010, as the deadline for intervenors and the Board's staff to file expert and factual testimony. The April 5, 2010, entry also ordered that the adjudicatory hearing in this matter be held on June 29, 2010.
- (4) On June 11, 2010, the applicant filed a motion for an extension of time pursuant to Rule 4906-7-13, O.A.C. The applicant requests three additional days for the filing of direct testimony related to sound issues. In support of its motion, the applicant states that, while its direct testimony presenting the application and the less technical siting issues, as well as the notices of publication, will be filed on June 15, 2010, it needs additional time to work with its consultants to insure that the record addressing some of the conditions suggested by the Board's staff is complete. In order to prevent any undue time constraint for the Board's staff or OFBF while preparing for the adjudicatory hearing, the applicant requests

that the Board's staff and OFBF also be granted three additional days, or until June 25, 2010, to file any direct testimony.

- (5) The applicant certifies that both counsel for the Board's staff and counsel for OFBF have agreed to the proposed revised filing dates.
- (6) The administrative law judge finds good cause exists to grant the applicant's motion for an extension of time. Accordingly, the due date for the filing of expert and factual testimony related to sound by the applicant should be extended to June 18, 2010, while the due date for the filing of expert and factual testimony by the Board's staff and OFBF should be extended to June 25, 2010.

It is, therefore,

ORDERED, That the applicant's motion for an extension of time be granted, and that the due date for the filing of expert and factual testimony related to sound by the applicant be extended to June 18, 2010, while the due date for the filing of expert and factual testimony by the Board's staff and OFBF be extended to June 25, 2010. It is, further,

ORDERED, That a copy of this entry be served upon all parties of record.
