

Response: IGS is a privately held corporation with no parent. In Illinois, it transacts business exclusively through its 100%-owned subsidiary, Interstate Gas Supply of Illinois, Inc. In Indiana, it has transacted business through its 100%-owned subsidiary, Interstate Gas Supply of Indiana, Inc.

Response: IGS is a privately held company founded in 1989 by Marv and Scott White. Cofounder Marv White was President and CEO of the Columbia Gas Distribution Companies when the first unregulated or "self help" natural gas program in the United States was implemented behind Columbia Gas of Ohio. Scott White has been intimately involved in the natural gas industry since the inception of the company, for over 21 years, and is one of the leaders in natural gas deregulation.

IGS has pursued a deliberate and precise marketing and management strategy since its inception. IGS has worked diligently over the past few years to improve the Ohio natural gas market to bring additional benefits to Choice and Commercial and Industrial customers. IGS believes that controlled growth achieves the most positive and lasting results, and provides the greatest stability. As such, IGS has slowly expanded its participation in choice programs throughout the Midwest and East coast over the past several years and will continue to pursue a controlled growth strategy. IGS has built its business on putting the customer first and will continue that strategy in the future.
