On June 16, 2010, CenturyTel Operating Companies filed Transmittal No. 80 with the Federal Communications Commission. The revisions made to Tariff F.C.C. 
Cost support material in accordance with Sections 61.38 and 61.41 through 61.49 of the Commission's Rules is provided, where required, for this filing.
