#### **ENTRY**

#### The Commission finds:

- (1) On August 23, 1999, Herbert Schirtzinger (complainant) filed a complaint against Citizens Utilities Company of Ohio (Citizens) alleging that the respondent acted negligently in cleaning out its blocked sewer lines, resulting in damages and losses for the complainant. On September 10, 1999, Citizens filed an answer to the complaint essentially denying all of its material allegations.
- (2) A prehearing settlement conference was held, as scheduled, on December 20, 1999. Although no settlement was reached on that day, thereafter, the parties continued working towards settlement.
- (3) On May 29, 2000, the complainant filed an application to withdraw the complaint. The notice states that the parties have resolved the matters raised in the proceeding and that the complaint is withdrawn.
- (4) Given the mutual settlement of the issues raised in the complaint, this case shall be dismissed.

It is, therefore,

ORDERED, That the complaint filed in this case be dismissed at the request of the complainants, and that this docket be closed a 1 matter of record. It is, further,

ORDERED, That a copy of this entry be served upon all parties of record.
