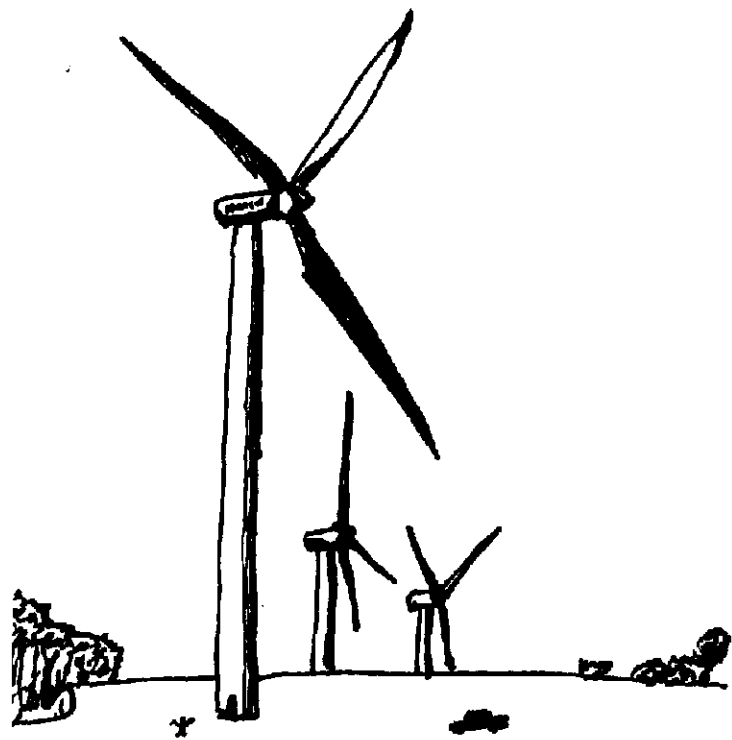
GREETINGS,

IBERDROLA IS ALSO "NOT FROM AROUND HERE". A REVIEW OF THEIR MAJOR SHAREHOLDERS SHOWS FEW IF ANY AMERICAN CITIZENS. MY OPPOSITION IS NOT TO THE WIND INDUSTRY AS MR. LITLHFIELD TESTIFIED, BUT TO ALL SCHEMES THAT TAKE MONEY FROM AVERAGE CITIZENS AND GIVE

IT AWAY IN LARGE DOSES TO FOREIGN CORPORATIONS.

MR. LITCHFIELD'S ARGUMENTS PERTINENT TO ME, BRETT HEFFNER, ARE UNSOUND, AND SHOULD BE COMPLETELY DISREGARDED. IF THE ARGUMENT PERSISTS, IT SHOULD BE BETWEEN THE TWO OF US UNDER OATH BEFORE THE ALJ.
