3.1 Pole and Anchor Attachment, Anchor and Associated Guy Strand Utilization and Conduit Occupancy (Cont'd)

3.1.2 Rates

	<u>Annual</u>
(A) Pole and Anchor Attachment	
Per pole Attached (Cable)	\$4.00
Per pole Attached (All others)	\$4.25
(B) Conduit Occupancy	
(1) Per foot of duct occupied	(See Note 1)
(2) For the purpose of determining the duct feed chargeable the duct considered occupied shall be measured from the:	
(a) center to center of adjacent manholes, or	
(b) center of a manhole to the end of a duct not terminated in a manhole.	

3.2 Charges - Nonrecurring

3.2.1 Determination

Charges for all work performed by the Telephone Company or by its authorized representative in connection with the furnishing of pole, anchor and conduit system accommodations as covered by this tariff shall be based upon the full cost, plus (10%) of such amount, to the Telephone Company for performance of such work. Such charges will apply for, but not be limited to, prelicense survey, make-ready work, inspection and removal of attachee's communications facilities and supervision, at the option of the Telephone Company, of attachee performed work in and around the immediate vicinity of a conduit system.

Note 1: Rates for customers as of April 14, 1998 are grandfathered at an annual rate of \$.80 per foot of duct occupied. Beginning April 14, 1998 all new Conduit Occupancy will be billed on an individual case basis (ICB) based on the methodology as prescribed by the FCC (currently the methodology detailed in the FCC Report and Order released February 6, 1998 in Docket No.98-20. The charge may be billed on either an annual, monthly or combination of annual and monthly basis.
