OF COUNSEL

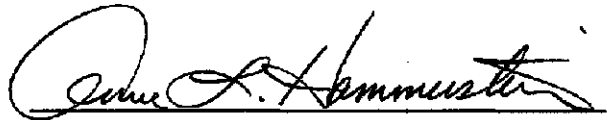
