
Pursuant to Ohio Administrative Code § 4901:1-14, Duke Energy Ohio, Inc. ("Duke Energy Ohio") respectfully requests that the Public Utility Commission of Ohio ("Commission") grant it leave to file, *instanter*, its Reply Comments.

In its Entry dated June 23, 2010 ("Entry"), the Commission issued proposed guidelines to establish uniform standards and specifications for fuel adjustment clause ("FAC") audits authorized statutorily through Ohio Revised Code § 4928.142(F)(1)-(2) and § 4928.143(B)(2)(a). The Commission sought comments to be filed on July 14, 2010 and Reply Comments by July 28, 2010. Duke Energy Ohio previously submitted its initial comments. Counsel missed the deadline, July 28, 2010, to file Duke Energy Ohio's Reply Comments.


