

MEMORANDUM IN SUPPORT

The parties in Case No. 10-595-GA-RDR have reviewed and discussed the comments filed on July 30, 2010 by Staff and OCC. It is believed that some or all of the issues raised therein may be resolved by further discussion. In order to permit that discussion, the parties believe that an extension of the dates for filing testimony and the date of the hearing should be extended. Dates under current consideration are as follows:

VEDO Testimony	August 16
Staff and Intervenor Testimony	August 20
Hearing	September 7

As discussions continue through the next few days, it will be possible for the parties to either confirm a request for the extensions listed above or make an alternative proposal for revised dates. For the moment, however, the parties seek approval to extend the scheduled dates for the filing of testimony and the hearing in these proceedings. 
