

**DUKE ENERGY OHIO'S STATEMENT
CONCERNING OUTSTANDING ISSUES**

As Ordered by the Attorney Examiner in her entry dated June 10, 2010, Duke Energy Ohio, Inc. ("Duke Energy Ohio") hereby informs the Commission that not all issues raised by all parties in this proceeding have been resolved. Even so, the parties have met to discuss the issues raised in this filing, and they are continuing to discuss whether means exist whereby the parties can resolve the issues among themselves and, potentially, present this Commission with a stipulation satisfactory to all.

For this reason, Duke Energy Ohio respectfully requests that it be provided an extension, of thirty (30) days, in which to present a stipulation by the parties proposing a resolution of the issues raised herein or inform the Commission that issues remain that the parties cannot resolve between themselves.


