## NOTICE THAT TURBINE LOCATION 108 WILL NOT BE DEVELOPED

Paulding Wind Farm II LLC ("Paulding Wind") in the matter at bar sought authorization to construct wind turbines for a wind farm not to exceed 150.4 MW. To accomplish this level of generation, the Application proposed sites and included studies for 109 turbines, though Paulding Wind only intends to construct 83 to 100 turbines depending on the model of turbine selected. This permitted Paulding Wind the flexibility of eliminating sites it considers less suitable for development taking into consideration information from the public and the Board Staff.

On August 4, 2010, Paulding Wind provided notice that four of the sites addressed in the Application (Turbine Locations 7, 8, 9 and 10), though fully in compliance with the Board's rules, will not be constructed as part of this Application.

Today, Paulding Wind has reached a point in its review where it can eliminate an additional site. Paulding Wind will not be developing turbine location 108 in the above-captioned matter. The location of turbine 108 can be found in the Application at Figure 05-4 Site Layout, Sheet Index.

Early notice that a site has been eliminated from consideration for construction is not required by the Board's rules, but Paulding Wind believes the general public and the Board Staff
