APPLICATION OF COLUMBIA GAS OF OHIO, INC.

Now comes the Applicant, Columbia Gas of Ohio, Inc. ("Columbia"), and applies for approval of revised bill formats for its Small General Service ("SGS"), General Service ("GS"), Large General Service ("LGS"), Full Requirements Small General Transportation Service ("FRSGTS"), Full Requirements General Transportation Service ("FRGTS") and Full Requirements Large General Transportation Service ("FRLGTS") customers who are billed through Columbia's Distributive Information, ("DIS") and Gas Measurement Billing ("GMB") systems. Columbia also requests approval of revised bill formats for its Small General Transportation Service ("SGTS"), General Transportation Service ("GTS") and Large General Transportation Service customers billed through Columbia's Gas Transportation Service ("GTS") billing system. Columbia makes this application pursuant to Ohio Administrative Code § 4901:1-13-11(D). In support of its application, Columbia states as follows:

1. Columbia is an Ohio corporation engaged in the business of supplying natural gas to consumers within the state of Ohio. Columbia is a public utility subject to the Commission's jurisdiction.

2. Ohio Administrative Code § 4901:1-18-09(C) requires any natural gas company under the Commission's jurisdiction to submit to the Commission for its approval any proposed

new bill format, and further provides that in the absence of any action by the Commission within forty five (45) days, the proposed new bill format shall be approved.

3. In Case No. 09-326-GA-ORD, by Finding and Order dated July 29, 2010, the Commission adopted amended Rules 4901:1-13-08 through 12 to become effective 45 days from the date these Rules were filed with Joint Committee on Agency Rule Review, the Secretary of State, and the Legislative Service Commission, or the earliest date possible, in accordance with divisions (D) and (E) of Section 111.15, Revised Code.

4. Paragraph (B)(11), Part 55, was revised to require the identification of the fixed monthly customer charge as a separate component of the bill.

5. Paragraph (B)(11), Part 57, requires that a company set forth in each customer bill the total charge attributable to the gross receipts tax, expressed in dollars and cents, and the gross receipts tax rate.

6. Pursuant to this Ohio Administrative Code § 4901:1-18-09(C), Columbia submits this application to revise its bill formats to reflect the above-referenced changes adopted by the Commission adopted in amended Rules 4901:1-13-08 through 12.

7. Attachment A is sample bill that reflects the changes to bills of SGS customers issued through Columbia's DIS billing system for the following reasons: (1) the identification of the fixed monthly delivery charge as a separate component of the bill; and (2) the identification of the gross receipts tax and tax rate used in computation of the total charge attributable to the gross receipts tax. In addition, at this time, Columbia further proposes to identify the amount of the Retail Price Adjustment referenced on the bill. To implement these changes Columbia proposes to revise the Service Charge Note shown on page 1 of the bill as follows:

"Current charges includes a fixed monthly delivery charge of \$XX.XX; gas cost recovery at an SSO rate of \$ XX.XX per Ccf; and gross receipts taxes of \$XX.XX computed at a rate of 4.987%. SSO rate equals NYMEX Closing price plus the Retail Price Adjustment of \$ X.XXX per Ccf divided by 10."

8. Attachment B is a sample bill that reflects the changes to bills of FRSGTS customers issued through Columbia's DIS billing system for the following reasons: (1) the identification of the fixed monthly delivery charge as a separate component of the bill; and (2) the identification of the gross receipts tax and tax rate used in computation of the total charge attributable to the gross receipts tax. To implement these changes Columbia proposes to revise the Service Charge Note shown on page 2 of the bill as follows:

"Current charges includes a fixed monthly delivery charge of \$XX.XX and a gross receipts taxes of \$XX.XX computed on the Total Columbia charges at a rate of 4.987%.

9. Attachment C is a sample bill that reflects the changes to bills of GS and LGS customers issued through Columbia's DIS billing system for the following reasons: (1) the identification of the customer charge as a separate component of the bill; and (2) the identification of the gross receipts tax rate used in computation of the total charge attributable to the gross receipts tax. In addition, at this time, Columbia further proposes to identify the amount of the Retail Price Adjustment referenced on the bill. To implement these changes Columbia proposes to revise the Service Charge Note shown on page 1 of the bill as follows:

"Current charges include a customer charge of \$XX.XX; gas cost recovery at an SSO rate of \$XX.XX per Ccf; and gross receipts taxes of \$XX.XX computed at a

rate of 4.987%. SSO rate equals NYMEX closing price plus the Retail Price Adjustment of \$X.XXX per Ccf divided by 10."

10. Attachment D is a sample bill that reflects the changes to bills of FRGTS and FRLGTS customers issued through Columbia's DIS billing system for the following reasons: (1) the identification of the customer charge as a separate component of the bill; and (2) the identification of the gross receipts tax rate used in computation of the total charge attributable to the gross receipts tax. To implement these changes Columbia proposes to revise the Service Charge Note shown on page 2 of the bill as follows:

"Current charges include a customer charge of \$XX.XX and a gross receipts tax of \$XX.XX computed on the Total Columbia charges at a rate of 4.987%.

11. Attachment E is a sample bill that reflects the changes to bills of SGS, FRSGTS, GTS and FRGTS customers billed issued through Columbia's GMB billing system to identify the gross receipts tax rate used in computation of the total charge attributable to the gross receipts tax. To implement these changes Columbia proposes to revise the note on page 1 of the bill, under General Information as follows:

"Current Charges include a Gross Receipts Tax of \$XX.XX computed at a rate of 4.987%".

12. Attachment F is a sample bill that reflects the changes to bills of SGTS, GTS and LGTS customers bills issued through Columbia's GTS billing system to identify the gross receipts tax rate used in computation of the total charge attributable to the gross receipts tax. To implement these changes Columbia proposes to revise the note on page 1 of the bill, under General Information as follows:

"Gross receipts tax is computed at a rate of 4.987%."

13. Columbia respectfully requests that the Commission approve this Application so that Columbia can implement the revised billing format with bills issued for the November 2010 billing cycle.

WHEREFORE, Columbia respectfully requests that the Commission approve the revised bill formats as proposed herein.
