Re: Motion to Dismiss (Case No. 10-1028-WW-CSS)


To Whom It May Concern:

On behalf of the Lake Mohawk Property Owners Association (LMPOA) Board of Directors, it is requested that case number 10-1028-WW-CSS be dismissed. It is the determination of the Board of Directors that the cost associated with pursuing the case against Mohawk Utilities (i.e. travel to Columbus) is far too great for the alleged infraction.

Although Mohawk Utilities has since taken corrective action, it was not before LMPOA acted to correct the problem. LMPOA is requesting that all costs associated with correcting the problem be reimbursed by Mohawk Utilities. The sum requested is \$111.05 (\$71.75 + tax for the valve and one hour labor at \$35.00 per hour). I have attached a copy of the receipt from the purchase of the valve.
