They system is a 68.64 kW solar array located on the ground next to Newcomerstown West Elementary School. Panels are tilted at a 15 degree angle and are facing South. The system includes re-enforced concrete curbs, geo-tec fabric, and trenching/gravel. The panels themselves are grouped into sets of 12 (physically separated into seven main sections). So the array is made up of 286 Sharp 240 watt modules. The 286 modules are wired as 24 strings of 12 modules in a series. PV wire...The inverter is a Solectria 60kW 3-ph 208 Vac with AC & DC disconnects, isolation transformer & display.

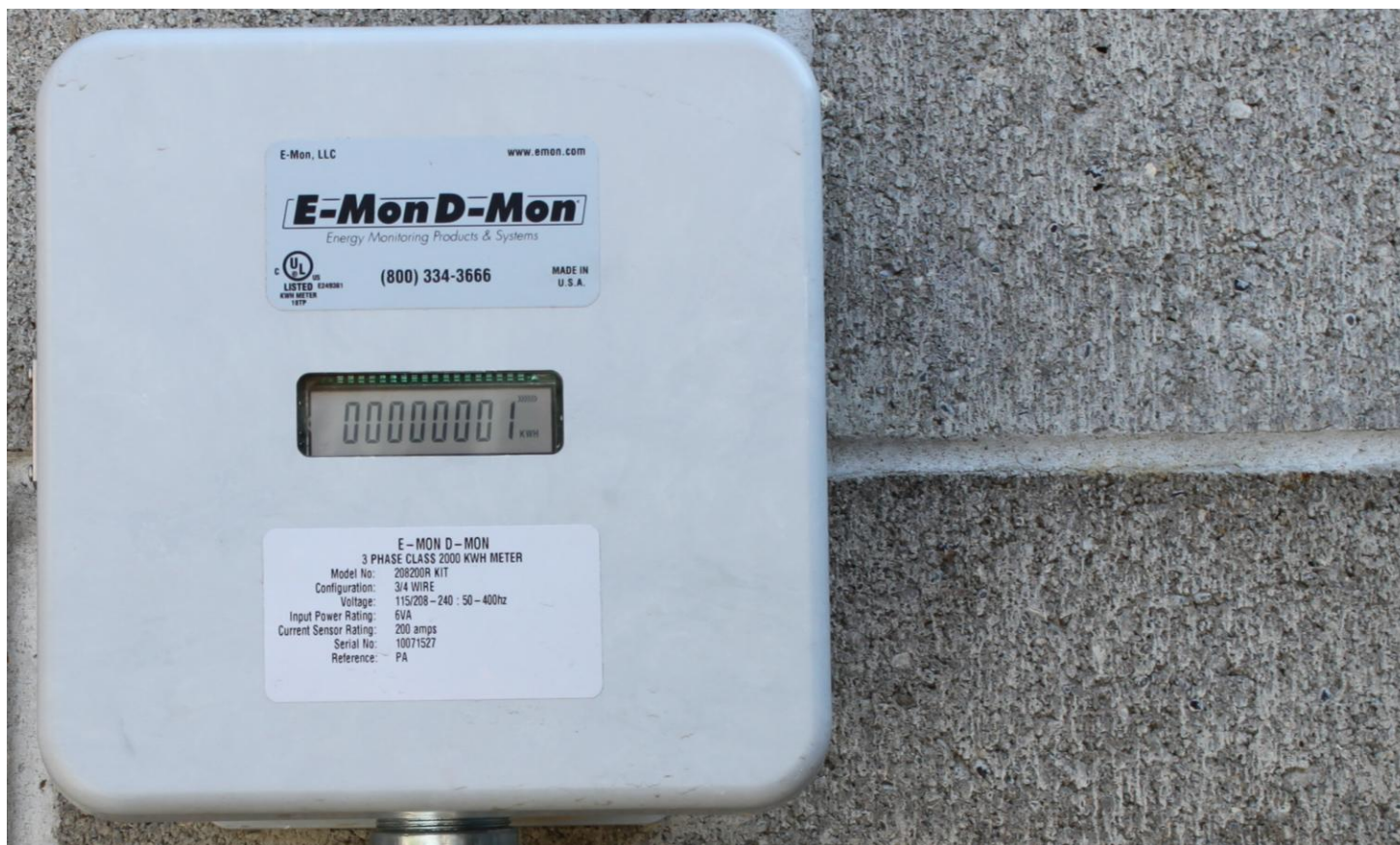
