Pursuant to Rule 4901:1-6-04(B) of the Ohio Administrative Code, please find attached an Application of Buckeye Telesystem, Inc. ("Buckeye") to amend its tariff PUCO No. 2 to add Elmore to its service area. Buckeye is already authorized to offer services in Ottawa County where Elmore is situated.



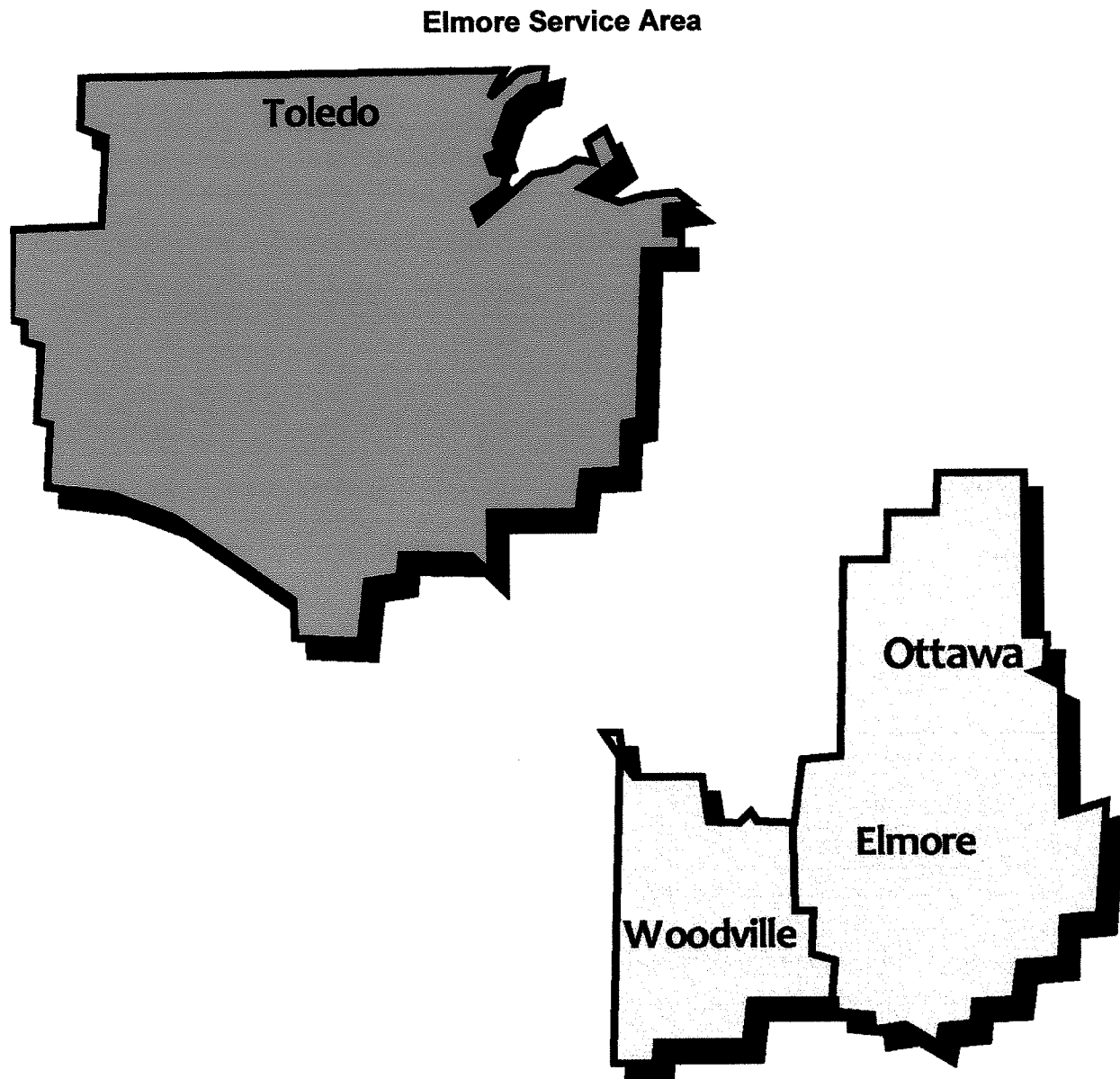
