RIDER USF Universal Service Fund Rider

A Universal Service charge of 0.16964¢ per kWh for the first 833,000 kWh and 0.10461¢ per kWh for the kWh above 833,000 kWh shall be added to the energy charge of all applicable rate schedules for the exclusive purposes of providing funding for the low-income customer assistance programs and for the Consumer Education Program authorized under Section 4928.56 of the Ohio Revised Code, and for paying the administrative costs of the low-income customer assistance programs and the Consumer Education Program.

This Universal Service Rider replaces the Interim Emergency and Temporary Percentage of Income Payment Plan Rider. Any service subject to the Interim Emergency and Temporary Percentage of Income Payment Plan Rider shall be subject to this Universal Service Rider instead.
