**Re: In the Matter of the Application for Establishment of a Reasonable Arrangement between The Cleveland Clinic Foundation and Ohio Edison Company, PUCO Case No. 10-2025-EL-EEC**

Dear Secretary Jenkins:

On August 3, 2010, The Cleveland Clinic Foundation ("Clinic") and Ohio Edison Company ("OE") submitted a joint application in this proceeding for approval of a reasonable arrangement ("Application"). The Application sought to commit energy efficiency projects completed by the Clinic at a number of its facilities towards OE's compliance obligations associated with Section 4928.66, Revised Code. In exchange for committing such projects, the Clinic requested that the Public Utilities Commission of Ohio ("Commission") authorize a cost recovery mechanism exemption [the DSE2 component of OE's Demand Side Management and Energy Efficiency Rider ("Rider DSE")] through December 31, 2019.

The Application included four sites served by OE that had completed energy efficiency projects, including a site identified in the Application as Elyria FHC.

The Clinic is no longer providing services at the Elyria FHC and the facility is being offered for sale. In light of these circumstances, the Clinic and OE would like to request that the Application be amended to remove this site.


