On December 17, 2010, CenturyTel Operating Companies filed Transmittal No. 84 with the Federal Communications Commission. The revisions made to Tariff F.C.C. No. 1 will become effective January 1, 2011. In this filing, CenturyLink adjusts the universal service fund (USF) and user contribution factor for the first quarter 2011 to 0.155 consistent with the requirements of the Commission's USF Order.¹


