**CORRECTED MOTION FOR EXTENSION OF TIME OF  
OHIO EDISON COMPANY**

Respondent Ohio Edison Company ("Ohio Edison") hereby moves the Public Utilities Commission of Ohio ("Commission") for a fourteen (14) day extension of time, up to and including January 21, 2011, to file an answer to the Complaint and respond to the data request in the above-captioned case. On December 20, 2010, the Attorney Examiner in this case entered an Order joining Ohio Edison as a party respondent and instructing Ohio Edison to file an answer on or before January 7, 2011. The Order also requested that Ohio Edison provide the Commission, by January 7, 2011, the names of all entities with attachments to its power pole in the backyard of Complainant's residence.

Counsel for Ohio Edison recently received the December 20, 2010 Order. A short extension of time is required so that Counsel may investigate the facts at issue in this case and appropriately respond to the Complaint and the Commission's request. An extension up to and including January 21, 2011 will not delay the proceedings in this case including the January 27, 2011 prehearing conference date. Moreover, counsel for CenturyTel of Ohio has indicated that

he does not oppose this extension of time. Consequently, Ohio Edison respectfully requests that the Commission grant it a fourteen (14) day extension of time up to and including January 21, 2011 to respond to the Complaint and data request contained in the Order.
