COLUMBUS SOUTHERN POWER COMPANY'S APPLICATION FOR APPROVAL OF A CHANGE IN BILL FORMAT AND REQUEST FOR AN EXPEDITED REVIEW

Pursuant to §4901:1-10-22 (C), Ohio Admin. Code, Columbus Southern Power Company (CSP) files this application for Commission approval of a change in the bill format CSP currently uses. CSP also requests that the Commission consider this application on an expedited basis because the underlying compliance tariffs they are based upon are also being filed on this day and are set to be effective January 14, 2011.

On December 1, 2010, the Commission approved changes to Columbus Southern Power's service to allow for experimental service offerings in time of day (TOD) service rates and direct load control (DLC) experimental service. The Commission ordered CSP to file, in final form, four complete copies of its tariff, consistent with the finding and order.

The Companies must update the language on the bill to reflect these tariff changes. The proposed format change would remove the current reference to "On-Peak Generation" and "Off-Peak Generation" to "High Cost Hours" and "Low Cost Hours" under the "Generation"




