




Upon application by Sue Steigerwald, Joan Heginbotham, Citizens for Keeping the All-Electric Promise and Bob Schmitt Homes, Inc. (collectively, "CKAP Parties") Michael W. Challender is hereby required to appear on January 27, 2011 at 10:00 a.m. at the offices of the Public Utilities Commission of Ohio, 180 E. Broad Street, 11<sup>th</sup> Floor, Columbus, Ohio 43215, and attend the hearing from day to day until called by the CKAP Parties to testify. The witness shall submit oral testimony concerning his duties while employed by FirstEnergy (i.e. the Ohio Edison Company, the Cleveland Electric Illuminating Company and the Toledo Edison Company, collectively referred to as "FirstEnergy"), including his understanding of sales contracts between representatives of FirstEnergy and residential customers and/or developers of residential housing. By example, and upon information and belief, Mr. Challender was employed by FirstEnergy and is knowledgeable concerning a letter and agreement dated March 13, 2000 between FirstEnergy and Bob Schmitt Homes, Inc. Mr. Challender was the author of that letter and agreement. The witness shall submit oral testimony regarding the letter,

agreements, any other contact or conversations with Bob Schmitt Homes, Inc., and other matters during his employment with FirstEnergy.

Mr. Challenger's full participation in the examination will facilitate a full and complete development of the case before the Commission, including the ultimate record upon which the Commission will base its decision.
