

In the matter of the 2010 Long-Term Forecast Report of the Duke Energy Ohio, Inc.) Case No. 10-503-EL-FOR)

On January 24, 2010, pursuant to Ohio Adm. Code Rule 4901-1-21(B), the Ohio Consumers' Counsel ("OCC") issued a notice for the oral deposition of Jim Northrup, Richard Stevie, Kevin Davis, Lee Barrett as well as all individuals whose testimony is filed on behalf of Duke Energy Ohio, Inc. ("Duke" or "Company") in the above-captioned proceeding. The depositions were scheduled for February 1, 2011, continuing from day to day thereafter until completed. Owing to the revised schedule for this case, including a new date upon which testimony must be submitted, the depositions are not expected to take place on February 1, 2011 as previously announced.

The above-mentioned depositions are not cancelled, but their date will be revised. The parties and the Commission will again be notified regarding final arrangements for the depositions.

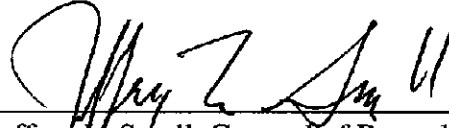

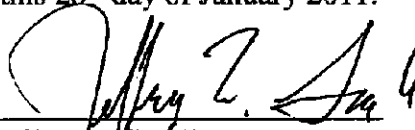
