Cincinnati Bell Telecommunications Services LLC (CBTS) is an AOS service provider. Concurrent with this filing, CBTS is filing an application in Case No. 11-615-TP-CIO to change BRCOM Inc.'s Certificate of Public Convenience and Necessity and tariff, BRCOM Inc. PUCO No. 1, to Cincinnati Bell Telecommunications Service LLC. The only services offered pursuant to the CBTS tariff are AOS services.

In accordance with Case No. 10-1010-TP-ORD, AOS services are to be removed from a company's tariffs. Thus, CBTS hereby files to withdraw and cancel its tariff, Cincinnati Bell Telecommunications Services LLC, PUCO No. 1, which contains only AOS services. In accordance with the Commission's Entry in Case No. 10-1010-TP-ORD issued on January 19, 2011, CBTS has attached the completed Telecommunications Retail Service Offering Form for Non-BLES Carriers to be used when filing to detariff services.

EXHIBIT A

Description and Rationale for Proposed Change, Customer Notice, and Tariff Cancellation

Cincinnati Bell Telecommunications Services LLC (CBTS) is a payphone service provider that provides AOS services within Ohio pursuant Cincinnati Bell Telecommunications Services LLC Tariff, PUCO No. 1, which was effective March 23, 1999. This payphone service is marketed to customers using the name "Cincinnati Bell."

The only services offered pursuant to the CBTS tariff are AOS services. AOS services are to be detariffed pursuant to Case No. 10-1010-TP-ORD. Thus, CBTS will no longer offer any services that are to be tariffed in Ohio, and CBTS is filing to withdraw and cancel its entire tariff, PUCO No. 1. CBTS has not included any tariff pages with this filing because CBTS will no longer have a tariff now that AOS services have been detariffed.

No customer notice is being provided because of the transient nature of payphone customers who would use CBTS' AOS services and because no changes will be apparent to users of CBTS services. That is, no rates, regulations, or services will change as a result of this filing.
