Code Rule 4901-1-21(B), please take notice that the Office of the Ohio Consumers' Counsel ("OCC") will take the oral deposition of the following individuals on March 14, 2011, or at a date and time as mutually agreed upon by OCC and AEP Ohio, and no later than one week prior to the presentation of any Columbus Southern Power Company and/or Ohio Power Company witness(es) for cross examination at the scheduled March 28, 2011 hearing:

- Power Company and any of its affiliates (collectively, "the Companies") in the instant cases;
- 2) All individuals, including employees or persons engaged on behalf of the Companies with knowledge or expertise as to the benefits derived or to be derived, financial and otherwise, by the Companies from the reasonable arrangements for electrical service between the Companies and Globe Metallurgical, Inc. and Solsil, Inc. that are the subject of these cases.
- All persons, including employees or persons engaged on behalf of the Companies who have been identified or will be identified as answering responses to discovery requests made in this proceeding.
- 4) All persons, including employees or persons engaged on behalf of the Companies who have knowledge and expertise as to the delta revenues expected to be collected under the Solsil and Globe arrangements.
- 5) All persons, including employees or persons engaged on behalf of the Companies who have knowledge and expertise as to the provider of last resort expenses/risk to be incurred under the arrangements with Solisl and Globe.

The depositions will take place at the offices of OCC, 10 West Broad Street, 18th Floor, Columbus, Ohio and will begin at such times as are mutually agreed upon by the Companies and the OCC, notwithstanding the fact that depositions will be taken no later

than one week prior to the appearance of the Companies' witnesses at the March 28, 2011 evidentiary hearing in these cases. Deponents will appear at the mutually agreed time with documents described below, and remain present until depositions are completed. Parties are invited to attend and cross-examine.

The depositions will be taken upon oral examination (as upon cross-examination) before an officer authorized by law to take depositions and will continue from day to day, except for holidays and weekends, until completed. Pursuant to Ohio Adm. Code Rules 4901-1-21(E) and 4901-1-20, the deponents are requested to produce three hours prior to the time of his or her scheduled deposition all documents relating to his testimony or the deponent's knowledge and expertise with respect to the above-identified subjects, including discovery responses that the deponents have answered or have responsibility for answering.
