MidAmerican Energy Holdings Company (incorporated) is a majority owned subsidiary of Berkshire Hathaway Inc., Omaha, Nebraska. The balance of MidAmerican Energy Holdings Company is owned by a private investor group comprised of businessman Walter Scott, Jr., and MidAmerican Energy Holding Company's President and Chief Executive Officer Gregory E. Abel.

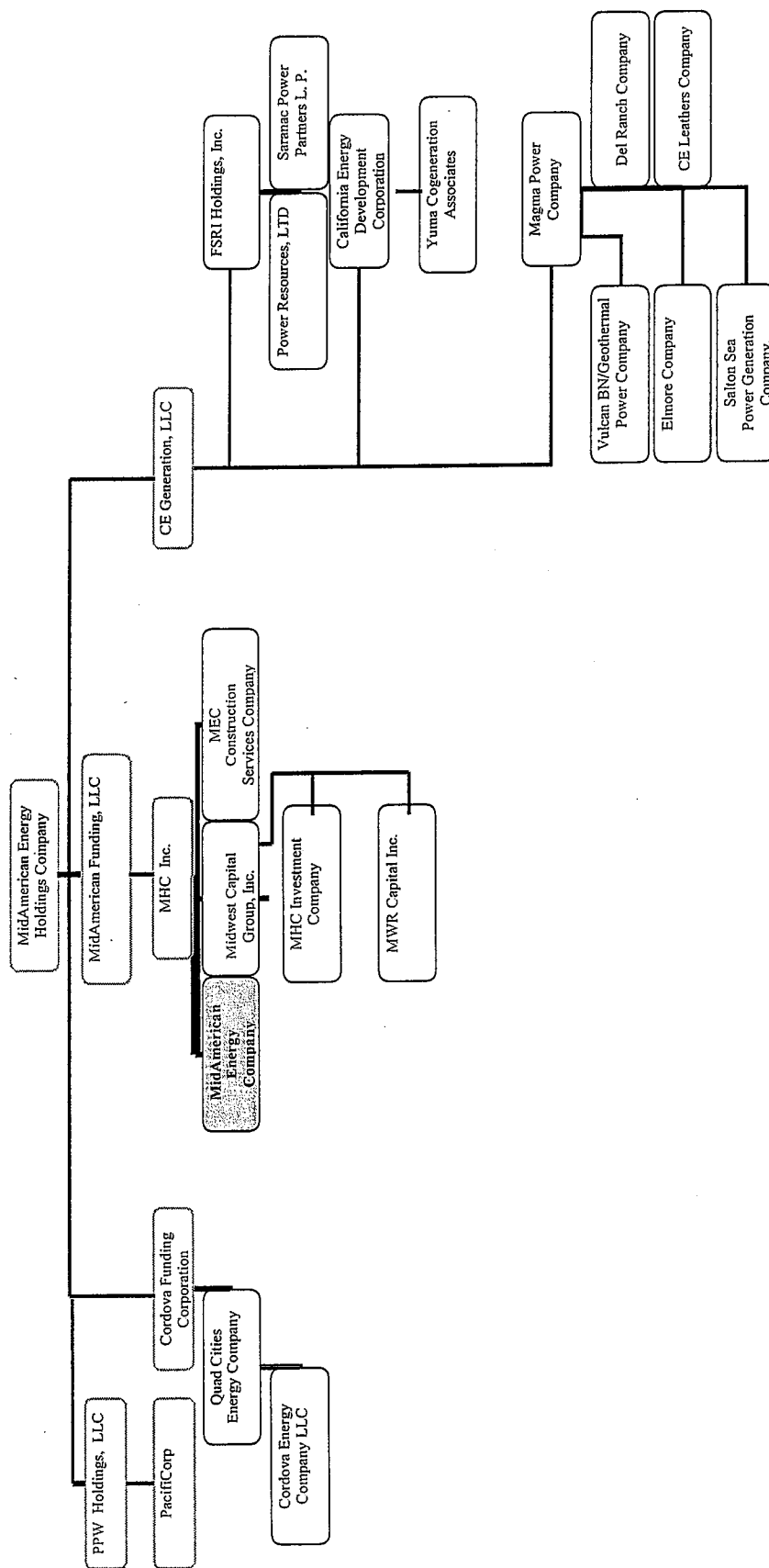

PacifiCorp is a regulated electric utility company serving approximately 1.6 million residential, commercial and industrial customers in service territories aggregating approximately 136,000 square miles in portions of the states of Utah, Oregon, Wyoming, Washington, Idaho and California.
