On March 17, 2011, CenturyLink Operating Companies' filed Transmittal No. 2 with the Federal Communications Commission. This filing will become effective April 1, 2011. In this filing, CenturyLink Operating Companies Tariff F.C.C. No. 1 adjusts the universal service fund (USF) end user contribution factor for 2nd quarter 2011 to 0.149 consistent with the requirements of the Commission's USF order.


