On March 3, 2011, Ameritech proposed various modifications to Tariff F.C.C. No. 2 and Tariff F.C.C. No. 3, in Transmittal No. 1730, which is scheduled to become effective on March 18, 2011. The modifications were to add definitions and clarify the legal name for the Issuing Carrier. Clean-up items were included to complete removal of Wideband Analog Video Service (WAVS) which was removed from Tariff FCC No. 2 on Transmittal No. 1729, which became effective on February 23, 2011. Additionally, the name and address of the Issuing Officer was being updated and moved to the Title Pages.

With this filing, Ameritech wishes to withdraw the tariff material filed under Transmittal 1730, without its becoming effective, and to restore currently effective material in order to review issues identified in the proposed modification.

(6) Other Non-recurring FUSF Surcharges

In addition to the applicable charges above, when a customer is assessed interstate end user charges identified in the table below, a FUSF Surcharge will also apply as set forth in Section 4.1.7(C) following.
