ENTRY

The attorney examiner finds:

- (1) On February 28, 2011, Duke Energy Ohio, Inc. (Duke) filed an application requesting an adjustment to its Accelerated Main Replacement Program (AMRP) Rider, consistent with the Commission's May 28, 2008, order approving the stipulation in *In the Matter of the Application of Duke Energy Ohio, Inc. for an Increase in Rates*, Case No. 07-589-GA-AIR, *et al.*
- (2) By entry issued March 3, 2011, the attorney examiner, *inter alia*, established the procedural schedule in this case. Specifically, the attorney examiner established a deadline of 9:00 a.m. on April 5, 2011, for filing any stipulation resolving some or all of the issues in these proceedings and scheduled the evidentiary hearing to commence on April 6, 2011.
- (3) On April 1, 2011, Duke filed a letter stating that the parties had reached a resolution in principle of all of the issues in these cases and that a stipulation would be filed on or before the April 5, 2011, deadline.
- (4) On April 5, 2011, the parties filed a joint motion requesting an extension of the deadline for filing their stipulation and a continuance of the hearing. In support of the motion, the parties state that, despite their best efforts, resolving the details of the stipulation has taken longer than anticipated and that they are unable to meet the April 5, 2011, deadline for filing the stipulation. The parties request that the deadline for submission of the stipulation be extended until April 8, 2011, and that the hearing be continued until April 12, 2011.


- (5) The attorney examiner finds that the parties' motion is reasonable and should be granted. Accordingly, the deadline for filing the stipulation should be extended until April 8, 2011. Additionally, the hearing in this matter should be continued until Tuesday, April 12, 2011, at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, 11th Floor, Hearing Room 11-D, Columbus, Ohio 43215-3793.

It is, therefore,

ORDERED, That the parties' motion be granted in accordance with finding (5). It is, further,


ORDERED, That a copy of this entry be served upon all parties of record.
