By Attorney Examiner Entry dated April 1, 2011, the Staff and all intervening parties were directed to file comments to AEP-Ohio's filing in this docket.


Due to the complexities of the case and heavy workloads, the Staff requests an extension of time in which to file comments to close of business on Friday, May 20, 2011.
