ENTRY

The attorney examiner finds:

- (1) On February 28, 2011, The East Ohio Gas Company d/b/a Dominion East Ohio (DEO) filed an application requesting an adjustment to its automated meter reading (AMR) cost recovery charge, consistent with the Commission's October 15, 2008, order approving the stipulation in *In the Matter of the Application of East Ohio Gas Company d/b/a Dominion East Ohio for Authority to Increase Rates for its Gas Distribution Service*, Case No. 07-829-GA-AIR, *et al.*
- (2) By entry issued March 3, 2011, the attorney examiner, *inter alia*, established the procedural schedule in this case. Specifically, the attorney examiner established a deadline of 9:00 a.m. on April 8, 2011, for filing any stipulation resolving some or all of the issues in this proceeding and scheduled the evidentiary hearing to commence on April 11, 2011.
- (3) On April 6, 2011, DEO filed a statement regarding disputed issues noting that the parties had reached a resolution in principle of all of the issues in these cases and that a stipulation would be filed by the April 8, 2011, deadline.
- (4) On April 8, 2011, Staff filed a motion requesting an extension of the deadline for filing the parties' stipulation and a continuance of the hearing. In support of the motion, Staff states that additional time is needed to finalize the stipulation and that no party opposes its motion. Staff requests that the deadline for submission of the stipulation be extended until April 11, 2011, at 9:00 a.m., and that the hearing be continued until April 12, 2011, at 9:00 a.m.


- (5) The attorney examiner finds that Staff's motion is reasonable and should be granted. Accordingly, the deadline for filing the stipulation should be extended until April 11, 2011, at 9:00 a.m. Additionally, the hearing in this matter should be continued until Tuesday, April 12, 2011, at 9:00 a.m., at the offices of the Commission, 180 East Broad Street, 11th Floor, Hearing Room 11-D, Columbus, Ohio 43215-3793.

It is, therefore,


ORDERED, That Staff's motion for an extension of the procedural schedule be granted in accordance with finding (5). It is, further,
