ALTERNATIVE ENERGY RESOURCES REPORT FOR CALENDAR YEAR 2010

Constellation NewEnergy, Inc. (hereinafter "CRES"), in accordance with Sections 4928.64 and 4928.65, Revised Code and Commission Rules 4901:1-40-03 and 4901:1-40-05, hereby submits this Annual Alternative Energy Report ("AER") detailing compliance with the Ohio Alternative Energy Portfolio Standards ("OH AEPS").

I. Determination that an Alternative Energy Resource Report is Required (check one)

During calendar year 2010, the CRES states that it conducted retail sales of generation to customers who utilized the generation in a load center located within the state of Ohio.

II. Determination of the sales baseline for 2010

- a. During the past three calendar years the CRES made retail sales of generation in the amounts shown below

- a. Column (a) above lists the unadjusted number of Solar and Total RECs Required for the CRES in 2010. The determinations were calculated by multiplying the Baseline Sales by 4 thousandths of one per cent (0.010%) for Solar RECs and one quarter of one quarter percent (0.50%) for total RECS. Total RECs include both Solar and Non Solar RECs.
- b. The CRES states that it has obtained the number of Solar and Non Solar RECs listed in column (b) above for 2010.
- c. The CRES used PJM GATS registry for the RECs detailed above.
- d. The CRES states that, of the RECs it has obtained for 2010, the number listed in column (d) represents the RECs with generation facilities sited within the state of Ohio.
- e. The CRES states that it did not seek a *force majeure* determination for Solar RECs for 2010.
- f. CRES states that it had obtained a *force majeure* determination for 2009 SRECs in the amount of SRECs located in OH and SRECs located in a state adjacent to OH. In addition to the SRECs listed in column (b) above, CRES has obtained an additional SRECs located in OH and SRECs located in a state adjacent to OH and has retired them with its 2010 compliance. A combined total of SRECs were retired, of which are located in OH. CRES believes it is now compliant for the 2009 and 2010 OH AEPS obligation

IV. Compliance (check one)

- CRES states that it has obtained the required number of Solar RECs and Total RECs without adjustments permitted pursuant to Rule 4901:1-40-05(A)(3).


d. Comments on any perceived impediment(s) to achieving compliance with the Solar and Non Solar REC requirements, as well as any discussion addressing such impediments.
