



**ADDENDUM TO CONTRACT FOR ELECTRICAL SERVICE  
SPECIAL TERMS AND CONDITIONS AGREEMENT  
Made a Part of Contract for Electric Service Dated July 11, 2008**

This Addendum supplements and amends the Electric Service Contract, as previously amended, dated July 11, 2008, by and between Ohio Power Company, hereafter called the Company, and Globe Metallurgical, Inc., hereafter called the Customer.

Pursuant to a Stipulation and Recommendation agreed to by Company and Customer dated November 9, 2010, as modified and amended by a Stipulation and Recommendation dated March 21, 2011, and adopted by the Public Utilities Commission of Ohio by an Order dated April 5, 2011 (Case No. 08-884-EL-AEC), the terms of which are incorporated herein, during the term of the Contract Customer's total discount will be as follows:

- For the period January 1, 2009 through December 31, 2011: 10% discount from the Company's then-current generation service rate including all applicable riders ("Big G"), implemented as specified in paragraphs 3-6 of the November 9, 2010 Stipulation and Recommendation. Pursuant to the above mentioned April 5, 2011 Order, the catch-up portion of the discount shall be effective on the first regular billing cycle subsequent to April 5, 2011 and extend through the end of the December 2011 billing cycle and the going forward discount shall begin as of the second billing cycle subsequent to April 5, 2011.
- For the period January 1, 2012 through December 31, 2018: 4.3% discount from the Company's current Big G rate, provided that employment level at the Customer is maintained at not less than 180 full-time employees. Discounts to the Company will increase in the event additional employees are hired in connection with the development of Solsil, Inc. as set out in paragraph 7 of the November 9, 2010 Stipulation and Recommendation.
