



ADDENDUM TO CONTRACT FOR ELECTRICAL SERVICE
SPECIAL TERMS AND CONDITIONS AGREEMENT
Made a Part of Contract for Electric Service Dated August 19, 2008

This Addendum supplements and amends the Electric Service Contract, as previously amended, dated August 19, 2008 by and between Columbus Southern Power Company, hereafter called the Company, and Solsil, Inc., hereafter called the Customer.

Pursuant to a Stipulation and Recommendation agreed to by the Company and Customer, dated November 9, 2010, as modified and amended by the Stipulation and Recommendation dated March 21, 2011, and adopted by the Public Utilities Commission of Ohio by an Order dated April 5, 2011 (Case No. 08-883-EL-AEC), the terms of which are incorporated herein, Company and Customer hereby agree that the Contract shall automatically terminate on December 31, 2013 if Globe Specialty Metals, Inc., on behalf of Customer, has not made a formal commitment on or before that date to proceed with the \$46 million investment in facilities located in Beverly, Ohio, as set out more fully in the original application for approval of the Contract.
