NOTICE OF NTIA LETTER SUBMITTAL

Black Fork Wind Energy, LLC ("Black Fork" or "the Applicant") hereby gives notice that it has submitted to the Staff of the Ohio Power Siting Board correspondence from the National Telecommunications and Information Administration ("NTIA"). The Applicant initially sought a waiver from Rule 4906-17-08(E)(4) to allow for the delayed submittal of the NTIA correspondence. After discussion with the Staff and agreement between the parties, the Applicant submitted a response brief on April 21, 2011 committing to provide this information prior to the end of the completeness review period. To that end, the Applicant has submitted to the Staff correspondence from the NTIA advising that after review, no federal agencies identified any concerns regarding blockage of their radio frequency transmissions from this project. A copy of the Applicant's correspondence to the Staff along with a copy of the NTIA correspondence is attached hereto.



Dear Mr. Hawken:

In response to your request on February 28, 2011, the National Telecommunications and Information Administration provided to the federal agencies represented in the Interdepartment Radio Advisory Committee (IRAC) the plans for the Black Fork Wind Project, located in Richland and Crawford Counties, Ohio.

After a 45 day period of review, no federal agencies identified any concerns regarding blockage of their radio frequency transmissions.

While the IRAC agencies did not identify any concerns regarding radio frequency blockage, this does not eliminate the need for the wind energy facilities to meet any other requirements specified by law related to these agencies. For example, this review by the IRAC does not eliminate any need that may exist to coordinate with the Federal Aviation Administration concerning flight obstruction.

Thank you for the opportunity to review these proposals.
