JOINT STATUS REPORT AND SECOND MOTION FOR
CONTINUED STAY OF PROCEEDINGS

Now comes Complainant, Cutter Exploration, Inc., ("Cutter Exploration") and Respondent, The East Ohio Gas Company d/b/a Dominion East Ohio ("DEO"), by and through their respective counsel, and hereby provide a joint status report to the Public Utilities Commission of Ohio (the "PUCO" or the "Commission"). Per the Commission's Entry of April 1, 2011, all proceedings in this matter were stayed in response to a joint motion filed by the parties on March 24, 2011. On May 5, 2011, the parties filed a Joint Status Report and Motion for Continued Stay of Proceedings (the "Joint Motion"). In the Joint Motion, the parties sought a one week extension of the stay through and until May 12, 2011.


Since the filing of the last status report the parties have continued to discuss settlement. With multiple issues being discussed, the parties have not been able to exhaust the settlement negotiation process within the limited extension period. Based upon the exchange of information and ongoing communications, counsel believe it would be beneficial to continue the process for an additional period of time before any action has to be taken in this matter pending before the PUCO. Accordingly, the parties respectfully move the Commission, the director or the attorney
