COLUMBUS SOUTHERN POWER COMPANY'S APPLICATION FOR APPROVAL OF A CHANGE IN BILL FORMAT AND REQUEST FOR AN EXPEDITED REVIEW


Pursuant to §4901:1-10-22 (C), Ohio Admin. Code, Columbus Southern Power Company (CSP) files this application for Commission approval of a change in bill format to be used by CSP for customers participating in Residential Time-of-Day (TOD) Service authorized in Case Nos. 10-424-EL-UNC. CSP also requests that the Commission consider this application on an expedited basis because the underlying compliance tariffs became effective on December 1, 2010.

CSP seeks to update the language on its bill, the original format of which was approved in the above-captioned docket on January 27, 2011. A copy of the proposed new format is made part of this application as Attachment 1. The new format uses CSP's new program name for TOD service, "SMART Shift", and provides a clear explanation of the customer's usage and savings, and generally presents the customer's information in a more user-friendly manner.

CSP has discussed with and provided the Commission staff with a copy of the requested format change to ensure their input was received before filing with the Commission. The Company is moving forward with this filing under the guidance of Commission Staff. CSP has also provided a copy of the proposed bill format to and obtained comments from the Office of Consumer's Counsel, who has previously intervened in this proceeding.

For these reasons, the Columbus Southern Power Company requests that the Commission approve their new bill format on an expedited basis.


