



- 2.1.1** To safeguard its interests, the Company may require the Customer to make a deposit to be held as a guarantee for the payment of charges. A deposit does not relieve the Customer of the responsibility for the prompt payment of bills on presentation.
- 2.1.2** A deposit may be required in addition to an advance payment.
- 2.1.3** Upon discontinuance of service, the Company will promptly refund the Customer's deposit plus accrued interest, or the balance, if any, in excess of the unpaid bills including any penalties assessed for service furnished by the Company.
- 2.1.4** Deposits held for 180 days or longer will accrue interest. Deposits held for less than 180 days will not accrue interest.

**2.2 Bad Check Charge**

A charge will be assessed for all checks returned by drawee bank or other financial institution for: Insufficient or uncollected funds, closed account, apparent tampering, missing signature or endorsement, or any other insufficiency or discrepancy necessitating return of the instrument at the discretion of the drawee bank or other financial institution.


