### <u>RESPONSE OF CINCINNATI BELL TELECOMMUNICATIONS</u> <u>SERVICES LLC TO MAY 19, 2011 ENTRY</u>

On May 19, 2011, the Commission issued an Entry in which it identified a number of "contributing carriers" as having failed to respond to the Commission's February 23, 2011 Entry that directed each such carrier to file data with the Commission. The May 19, 2011 Entry listed "Cincinnati Bell Telecommunications Services, Inc." ("CBTS, Inc.") as an entity that had failed to respond. As explained herein, CBTS, Inc. should not have been included on the list.

The Commission originally certificated CBTS, Inc. in Case No. 90-5859-CT-TRF. On November 30, 2007 CBTS, Inc. filed notice in that docket and a parallel Application for Change in Operations, Case No. 07-1222-TP-CIO, stating that its assets had been transferred to BRCOM Inc. BRCOM Inc. filed revised tariff pages to reflect the change in the company name to "BRCOM Inc." The Commission issued a new certificate noting the name change, which is attached hereto.

On February 4, 2011, a similar notice and Application for Change in Operations was filed by Cincinnati Bell Telecommunications Services LLC in both Case 90-5859 and Case No. 11-615-TP-CIO, informing the Commission that the assets of BRCOM Inc. had been transferred to CBTS LLC and changing the name in the BRCOM Inc. tariff to CBTS LLC. The Commission issued a new certificate to CBTS, LLC noting the name change, which is also attached hereto. Accordingly, CBTS LLC is the successor in interest to CBTS, Inc. through BRCOM Inc. On May 4, 2011, the Cincinnati Bell companies filed an amended data response with the Commission in this docket that included the responses of CBTS LLC to the data requests. CBTS LLC is the successor in interest to CBTS, Inc. and is in compliance with the Commission's February 23, 2011 Entry. Therefore, CBTS Inc. should not have been identified in the May 19, 2011 Entry as out of compliance. CBTS LLC requests that the Commission amend its records to remove CBTS, Inc. from the list of delinquent respondents.
