Thank you for note. The Seneca County Engineer's Department worked to correct approach deficiencies to the noted crossing prior to our road paving program a couple years ago. Part of the project was to relocate the driveway (further west) for the landowner to improve safety and to provide the required area for grading on the shoulder. This relocation also provided a smoother transition for the driveway from road grade to average ground. This department is in full support of the proposal and do not anticipate any opposition.
