PLEASE TAKE NOTICE that pursuant to Rule 4901-1-21 of the Ohio Administrative Code ("OAC"), Interstate Gas Supply, Inc. ("IGS") will take the deposition of one or more of the Office of the Ohio Consumers' Counsel's ("OCC") officers, agents, employees, or other persons duly authorized to testify on its behalf in the above captioned proceeding. 


